

ORDINANCE #1086

AN ORDINANCE OF THE BOROUGH OF OCEANPORT, COUNTY OF MONMOUTH, STATE OF NEW JERSEY CREATING POSITIONS FOR COURT VIOLATIONS CLERK AND PUBLIC WORKS MANAGER AND SETTING THE SALARY RANGE FOR SAME

WHEREAS, pursuant to N.J.S.A. 40A:9-165, the Borough Council shall set forth the salaries, wages or compensation of the officers and employees of the Borough of Oceanport, who, by law, are entitled to salaries, wages or compensation, subject to any respective collective bargaining agreement applicable to such positions; and

WHEREAS, the Mayor, Borough Administrator and Finance & Administration Committee have recommended the creation of the position "Court Violations Clerk" in the Municipal Court Office as support staff for the Court Administrator and the Borough Council desires to implement same; and

WHEREAS, the Public Works Committee has recommended the creation of the position "Public Works Manager" to support the Superintendent of Public Works in the day to day demands of the Department and the Borough Council desires to implement same,

NOW THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Oceanport, in the County of Monmouth, State of New Jersey that the following sections of the ordinance entitled "An Ordinance to Fix and Determine the Salaries of Certain Borough Officials" passed and approved on March 16, 1939, as last revised and passed on September 21, 2023 is hereby amended to include the following official employment designations and the range of compensation of each as follows:

SECTION 3. Department of Public Works
