

## REGULAR MEETING MINUTES

Oceanport, New Jersey  
January 7, 2010

The Regular Meeting of the Oceanport Mayor and Council was called to order on January 7, 2010 at 7:30 P.M. with Mayor Mahon stating the meeting had been properly advertised in accordance with the law.

The Clerk stated there were 17 items with one addition and described the additional item on the consent agenda and asked for a motion. Councilman Irace made a motion to approve the Consent agenda which was seconded by Councilman Johnson and approved by Council with Councilman Bertekap abstaining from Items 14, 15, 16 and 17, Councilman Briscione abstaining from Item 14 and Councilwoman Kahle abstaining from Items 14, 15, 16 & 17.

**CLERK/ADMINISTRATOR REPORT:** No report

**COMMITTEES:**

**COUNCILMAN BERTEKAP:** No report

**COUNCILMAN BRISCIONE:** Councilman Briscione stated he had no report but did offer comments regarding the racing industry and changes going on in nearby states and that it was something they needed to continue to monitor.

Mayor Mahon suggested to Council that perhaps they should consider a committee to officially represent Oceanport on the Monmouth Park issue. There was some additional discussion about representation which Council agreed.

**COUNCILMAN GALLO:** No report

**COUNCILMAN IRACE:** Councilman irace stated that the Finance Committee would be working on the 2010 municipal budget and that they would be working with a flat budget and have notified the Capital Improvement Committee and Borough Department heads that there would be no capital improvements for 2010 with the exception of infrastructure such as road and sidewalk projects. Councilman Irace stated that they were also discussing the best use of the planning reimbursement.

Mayor Mahon asked the Finance Committee to provide input and guidance to the Recreation Committee concerning the park improvement program which operates separate from the Capital fund as Trinity Park Grant application with Monmouth County was not successful.

Councilman Briscione also commented that the Borough had completed the reassessment and numbers were down by about 25% and that going forward it would be substantially less.

**COUNCILMAN JOHNSON:**

1. Introduction of a Capital Improvement Fund Ordinance for improvement to Borough buildings

Councilman Johnson called for the introduction of **AN ORDINANCE PROVIDING FOR IMPROVEMENTS TO CERTAIN BOROUGH BUILDINGS IN AND BY THE BOROUGH OF OCEANPORT, IN THE COUNTY OF MONMOUTH, NEW JERSEY, APPROPRIATING \$30,000.00 THEREFORE** and then asked the Clerk to read the proposed Ordinance by title only, after which Councilman Johnson moved to approve the Ordinance upon first reading and to hold the public hearing on the proposed ordinance at the Council meeting of January 21, 2010 and to advertise same in accordance with the law and was seconded by Councilman Irace.

As there was no further business, the meeting was adjourned at 9:01 p.m. on a motion by Councilwoman Kahle, which was seconded by Councilman Johnson and approved by Council.
