

## REGULAR MEETING MINUTES

Oceanport, New Jersey  
February 4, 2010

The Regular Meeting of the Oceanport Mayor and Council was called to order on February 4, 2010 at 8:25 P.M. with Mayor Mahon stating the meeting had been properly advertised in accordance with the law.

**PLEDGE OF ALLEGIANCE:** Mayor Mahon led the audience and members of the Council in the flag salute.

The Clerk stated there were 7 items on the consent agenda and asked for a motion. Councilman Irace made a motion to approve the Consent agenda which was seconded by Councilman Johnson and approved by Council with the exception of Councilman Briscione whom abstained from Items 5 and 7 and Councilwoman Kahle whom abstained from Item 6.

**CLERK/ADMINISTRATOR REPORT:** No report

### COMMITTEES:

**COUNCILMAN BRISCIONE:** Councilman Briscione reported on Public Safety including the reorganization meeting of the fire department, recent break ins and theft of valuables in town and surrounding towns and urged everyone to keep cars locked, remove valuables and report any suspicious activity to the police. Councilman Briscione also reminded residents that there was to be no parking on streets when they are snow covered and why due to the forecasted snowstorm.

Councilman Briscione also commented on the letter to residents sent by the Administrator's office regarding the new sanitation servicer and new curbside recycling for newspaper and cardboard and how they should be prepared and that additional information was available on the Borough's website.

**COUNCILMAN GALLO:** No report

**COUNCILMAN IRACE:** Councilman Irace commented on earlier discussion during the Workshop meeting regarding Senate bill S-10 and the frustration that they are experiencing with the processes for that issue as well as the horseracing industry issues and thanked Mayor Mahon and Mr. Bennett for the countless hours of work on the issues.

Councilman Irace also congratulated Katie LaPorta on her appointment to the sewerage authority.

**COUNCILMAN JOHNSON:** Councilman Johnson stated he had no report but also congratulated Katie LaPorta on her appointment.

**COUNCILWOMAN KAHLE:** Councilwoman Kahle announced that the environmental partnership along with the Bay Shore Watershed Council were sponsoring a Walk Along the Hook and gave event details.

Councilwoman Kahle also advised about a JCP&L program open to all residents whereas they place a monitor on air conditioning units that would automatically reduce energy in the event of a power surge and gave additional details on the savings the program anticipates and encouraged everyone to participate.

Councilwoman Kahle reported that the Quality of Life Committee would be continuing with the Welcome to Oceanport sign program in sponsor with Monmouth Park and sponsorship were available with more information available on the Borough website.

Councilwoman Kahle lastly thanked Mayor Mahon and Administrator Kim Jungfer's assistance in declaring February as Heart Month and commented on the history and the importance of the issue and encouraged everyone to wear red on Friday, February 5 in support of National Wear Red for Women's Day and then read a Proclamation issued by the Mayor's office declaring February as Heart Month.

**MAYOR MAHON:**

The Mayor then opened the meeting for anyone from the public who wished to be heard. As no one from the public wished to be heard the Mayor closed that portion of the meeting.
