## PETITION FILING INSTRUCTIONS FOR THE OFFICE OF COUNTY COMMITTEE

#### WHEN AND WHERE TO FILE:

Petitions for the Office of County Committee must be filed with your **Municipal Clerk**, **on or before 4:00pm**, **71 days before the date of the Primary Election**. Timelines for the Primary & General elections can be found on, <a href="https://www.monmouthcountyvotes.com/elections/election-timelines/">https://www.monmouthcountyvotes.com/elections/election-timelines/</a> or on <a href="https://njelections.org/">https://njelections.org/</a>. Please be advised timelines are subject to change throughout the year as new laws are enacted.

### **NUMBER OF SIGNATURES:**

Contact your Municipal Clerk for the number of signatures required or, in alternate, at least 10. **To be eligible to sign, a signer MUST be from the same political party or unaffiliated, and be a resident and registered voter of the district.** Contact information for your Municipal Clerk can be found on our website, <a href="https://www.monmouthcountyvotes.com/contact/municipal-clerks/">https://www.monmouthcountyvotes.com/contact/municipal-clerks/</a>

#### **HOW TO COMPLETE A PETITION:**

- 1. Read the Petition carefully and fill in all blank spaces where required.
- 2. Page 2, fill out where indicated: the name of the municipality, Election District #, Political party (Democratic or Republican), candidate's name, candidate's residential address, and a functioning campaign email address for each candidate.
- 3. On signature pages (Pages 3 & 4), place the candidate's name, the title of office, and election district # on the top line indicted.
- 4. All signers must print their name, sign, and give their residence address.
- 5. Page 5 is the Affidavit of Person Who Circulates This Petition and Witnesses Signatures. The witness taking the affidavit must be the person who obtained the names on that set of signatures for the petition. The witness must take the affidavit for each set he/she solicits and sign it in the presence of the person authorized to administer affidavits. The person who administers the affidavit cannot be the candidate. Please review Page 5, for the full list of qualifications required to be a circulator/witness of the petition. The candidate can be the witness/circulator.
- 6. Pages 6 & 7 are the *Oath of Allegiance* and *Certificate of Acceptance*. Each candidate only needs to fill out and sign said *oath* and *certificate* **once**. The *Oath of Allegiance* must be signed in the presence of the person authorized to administer affidavits. The person who administers the affidavit cannot be the candidate.
- 7. Page 8 is the Candidates' Request for Designation and Grouping on the Primary Ballot. This form is for candidates who are running for the same office and same term and is to be filed with your Municipal Clerk along with the rest of your petition. Fill out where indicated on this page: the name of the municipality, candidate's name, candidate's signature, office, and election district, and your designation/slogan. An Affidavit is not required for this page.
- 8. Pages 9 & 10 are the *Request for Position on Ballot*. This form is only required if you wish to appear on the ballot in the same column or row as candidates who are running for the office of County Commissioner. This form is to be filed with the **Monmouth County Clerk on or before two days after the last day for filing petitions.** Each candidate only needs to fill out and sign said request **once**. Be sure to fill out the candidate's name, municipality, election district #, and designation/slogan where indicated. Candidates must also sign and date this form. An Affidavit is not required for this page.
